- No one but the licensee/permittee will be able to pick up the merchandise UNLESS the RELEASE FORM / AUTHORIZATION FOR PICKUP FORM is provided to us by the licensee/permitee prior to pickup. This must be done every year. Person picking up Professional Fireworks must be at least 18 years old.
